## Section 4 - First Aid Measures

**INHALATION:** If Inhaled: Remove person to fresh air and keep comfortable for breathing. If breathing difficulty persists, seek medical attention.

**EYE CONTACT:** Rinse continuously with water for several minutes. Remove contact lenses, if present and easy to do. Continue rinsing for a minimum of 15 minutes while holding eye lids open. If eye irritation persist: seek medical attention.

**Ingestion:** Can cause central nervous system (CNS) depression. May be fatal if swallowed and enters airways. Irritating to mouth, throat and stomach.

**Extinguishing Media:** Dry Chemical, Foam, CO2 or water fog.

**Unsuitable Extinguishing Media:** High volume water jets

**Unusual Fire and Explosion Hazards:** Vapors can travel to a source of ignition and flash back. Closed containers may explode when exposed to extreme heat or burst when contaminated with water (CO2 gas evolved). Hazards apply to empty containers. Combustion generates toxic fumes.

## Section 6 - Accidental Release Measures

### **Personal precautions, protective equipment and emergency procedures:**

Use personal protective equipment. Avoid breathing vapors and mist. Ensure adequate ventilation. Eliminate all sources of ignition. Evacuate personnel to safe areas. Beware of vapors accumulation to form explosive concentrations. Vapors can accumulate in low areas.

For personal protection see section 8.

### **Environmental precautions:**

Prevent further leakage or spillage if safe to do so. Do not let product enter drains.

### **Methods and materials for containment and cleaning up:**

**Small Spills:** Stop leak if without risk. Move containers from spill area. Use spark-proof tools and explosion-proof equipment. Absorb with an inert dry material and place in an appropriate waste disposal container. Dispose of via a licensed waste disposal contractor.

**Large Spills:** Stop leak if without risk. Move containers from spill area. Use spark-proof tools and explosion-proof equipment. Approach release from upwind. Prevent entry into sewers, water courses, basements or confined areas. Contain and collect spillage with non-combustible, absorbent material e.g. sand, earth, vermiculite or diatomaceous earth and place in container for disposal according to local regulations. Dispose of via a licensed waste disposal contractor. Contaminated absorbent material may pose the same hazard as the spilled product.

## Section 7 - Handling and Storage

**Safe Handling Measures:** Avoid contact with skin and eyes. Avoid inhalation of vapor or mist. Ground and bond container and receiving equipment. Use non-sparking tools and explosion proof equipment when handling this material. Keep away from sources of ignition - No Smoking. Use in cool, well-ventilated areas. Keep containers closed when not in use. Take measures to prevent the build up of electrostatic charge. Follow all SDS and label precautions even after container is emptied because they may retain product residues. For precautions see section 2.

**General Occupational Hygiene:** Eating, drinking and smoking should be prohibited in areas where this material is handled, stored and processed. Workers should wash hands and face before eating, drinking and smoking. Remove contaminated clothing and protective equipment before entering eating areas. See also Section 8 for additional information on hygiene measures.

**Storage Requirements:** Keep container tightly closed. Keep away from heat, sparks, open flames and hot surfaces-No Smoking. Store in a cool, dry and well-ventilated place. Do not reuse container when empty.

**Engineering Controls:** Ground and bond container and receiving equipment. Use explosion proof electrical, ventilation, lighting and motorized equipment. Use non-sparking tools. Ensure adequate ventilation.

**Ventilation:** General mechanical ventilation or local exhaust should be utilized to keep vapor concentrations below exposure limits (PEL & TLV). Ventilation equipment must be explosion proof.

**Safe Work Practices:** Eye washes and safety showers in the workplace are recommended. Avoid contact with skin and eyes. Avoid breathing vapors. Wash hands thoroughly after using and before eating, drinking or smoking. Employee education and training in the safe use and handling of this product is required under the OSHA Hazard Communication Standard 29CFR1200. Smoking in area where this material is used should be strictly prohibited. Always use protective clothing and equipment. Remove all contaminated clothing and wash thoroughly when finished working. Keep food and drink away from material and from area where material is being used. Spraying of material can cause an oxygen deficient environment. Use proper ventilation to remove vapors, mist and fumes combined with NIOSH approved respirator.

**Respiratory Protection:** When working with this material use a MSHA/NIOSH approved cartridge respirator or suitable respiratory protection to keep airborne mists and vapor concentrations below the PEL & TLV limits. When using in poorly ventilated and confined spaces, use a fresh-air supplying respirator or a self-contained breathing apparatus.

**Effects of Overexposure**

Short Term Exposure

Ethyl benzene irritates the eyes, skin, and respiratory tract. Exposure to high concentrations can cause dizziness, lightheadedness and unconsciousness. Very high exposures (above the OEL) can cause difficult breathing, narcosis, coma, and even death. Swallowing the liquid may cause aspiration into the lungs, resulting in chemical pneumonitis. May affect the central nervous system. Concentration of 200 ppm can cause irritation. Inhalation: Exposure to vapor can be irritation to the nose and throat. Inhalation of vapor at concentrations above 200 ppm or 3 - 5 minutes can lead to xylene intoxication. Symptoms include headache, dizziness, nausea and vomiting. If exposure should continue, central nervous system depression characterized by shallow breathing and weak pulse can occur. Levels of 230 ppm for 15 minutes may cause lightheadedness without loss of equilibrium. Reversible liver and kidney damage in man has followed exposure to sudden high concentrations of vapor. Such high levels may also give rise to lung congestion. Exposure to extremely high concentrations (10,000 ppm or more) of xylene vapors can lead to a strong narcotic effect with symptoms of slurred speech, stupor fatigue, confusion, unconsciousness, coma, and possible death. The substance irritates the eyes, skin, and respiratory tract. High exposures, above the occupational exposure levels, can cause weakness, headache, and drowsiness and may cause unconsciousness. Contact can irritate the skin. Exposure can irritate the eyes and respiratory tract. Exposure to high concentrations can cause dizziness, lightheadedness, and unconsciousness. Methyl n-amyl ketone can affect you when breathed in and by passing through your skin. Irritates the eyes and the respiratory tract. May affect the central nervous system. Breathing the vapor can cause dizziness and lightheadedness, and can make you pass out.

Long Term Exposure

Repeated or prolonged exposure to the skin may cause drying, scaling and blistering. May cause kidney disease, liver disease, chronic respiratory disease, skin disease, as follows: EB is not nephrotoxic. Concern is expressed because the kidney is the primary route of excretion of EB and its metabolites. EB is not hepatotoxic. Since EB is metabolized by the liver, concern is expressed for these tissues. Exacerbation of pulmonary pathology might occur following exposure to EB. Individuals with impaired pulmonary function might be at risk. EB is a defating agent and may cause dermatitis following prolonged exposure. Individuals with preexisting skin problems may be more sensitive to EB. There is limited evidence that EB may damage the developing fetus, and may cause mutations. Inhalation of xylene vapor and skin contact with liquid are the two most probable routes of long term exposure. Symptoms of inhalation are dizziness, headache and nausea. Long term exposure has been associated with liver and kidney damage, intestinal tract disturbances and central nervous system depression. Prolonged contact with skin can lead to irritation, dryness and cracking. Repeated exposure can cause poor memory, difficulty in concentration, and other brain effects. It can also cause damage to the eye surface. n-Butyl acetate may cause skin allergy. n-Butyl acetate has been shown to damage the developing fetus in animals. Prolonged and repeated exposure to butyl acetates can cause defatting, drying and cracking of the skin. Although many solvents and petroleum based products cause lung, brain and nerve damage, these chemicals have not been adequately evaluated to determine these effects. Repeated skin exposure can cause dryness and skin cracking. This chemical has not been adequately evaluated to determine whether brain or nerve damage could occur with repeated exposure. However, many solvents and other petroleum-based chemicals have been shown to cause such damage. Effects may include reduced memory and concentration, personality changes (withdrawal, irritability), and fatigue, sleep disturbances, reduced coordination, and/or effects on the nerves to the arms and legs (weakness, "pins and needles"). Causes skin irritation with cracking and drying; destroys the skin's natural oils. May cause liver and kidney damage. May affect the nervous system.

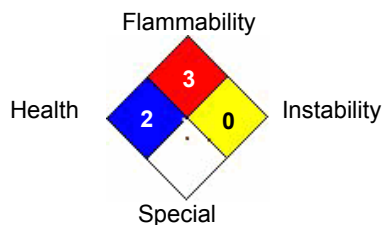
